4-Way Reconciliation

Statutory Compliance, Periodic Reports, OSS, ALM, Audit Reports

GST Software

GST was Launched in India in 2017. The GST launch completely changed the central and state govt taxation system. All taxes were merged into a single GST tax AND earlier Taxation returns processes were completely changed. TSSIPL provided an End-to-End GST Compliance solution to CDCC which provided complete solution for Service Charges Invoicing, GSTR 1 Returns, Expenditure Recording and Purchase Invoice Recording, GSTR2A reconciliation, ITC Determination AND GSTR 3B Returns.
